ady of the Sea administration received official confirmation in mid-July that FEMA has approved the replacement of the main hospital facility.

"This is great news for the South Lafourche community," said Dr. Lloyd J. Guidry, Jr., CEO of Lady of the Sea General Hospital.

"What this official confirmation means is that FEMA will provide 90% of funding, minus the insurance collected, to build a new, modern, code-compliant facility that will be designed with an emphasis on mitigation and resiliency to ensure it withstands any future storms that threaten our community."

The FEMA funding obligation is currently in Expert Review with the US Army Corps of Engineers (USACE). Although administration had started working with architects and had even chosen a CMAR (Construction Manager at Risk), the hospital was still waiting on official word that the replacement was going to be the option chosen before proceeding any further. "By working with a CMAR, we will get ahead of long lead items and supply chain issues, which leads to a quicker, smoother construction. If all continues according to plan, we could be opening the permanent hospital in the summer of 2025," said Tad Lafont, COO of Lady of the Sea General Hospital. Architect's renditions of the permanent facility have already been publicized and are included on this page and the front cover. "Not only is it aesthetically appealing, but it's also designed to ensure our community hospital will be functional for decades to come no matter what mother nature decides to throw our way," Lafont reported.

Finally, the return of hospital services is within our grasp. After working through the necessary processes, laws and codes to build a temporary facility, the building is on our campus, and the opening date is currently scheduled for the end of 2023.









"This temporary hospital will bridge the gap of inpatient services while we continue to work toward building the new permanent hospital," said Lloyd Guidry, Jr., Pharm.D., CEO of Lady of the Sea General Hospital.





"The temporary facility is constructed of modular buildings that are rated to withstand up to Category 4 (130-156 mph) hurricane winds. It covers over 28,000 square feet and really offers our employees a great place to offer healthcare to our community."

DIALYSIS CENTER Grand RE-Opening!





"We are happy to welcome back our dialysis patients who have been receiving treatment outside of our community and in a temporary unit on our campus." ady of the Sea General Hospital held a ribbon cutting and open house on May 4th to celebrate the re-opening of the Dialysis Unit. Dialysis is a critical treatment for people with Kidney Failure or End Stage Renal Disease. Without dialysis treatment, which is usually administered three times each week, these patients may not survive. For this reason, it was important to Lady of the Sea Administration to get the Dialysis Unit back in service following it's closing from Hurricane Ida damage.

"We were able to begin the construction work on the dialysis building in October of 2022 following approval and funding obligation from FEMA. We are very pleased with the outcome of this project," said Dr. Lloyd Guidry, Jr., Chief Executive Officer at Lady of the Sea. "This permanent unit brings to the patients the best in dialysis treatment."

"This unit has state-of-the-art equipment in the water room and treatment area," said Holly Griffin, RN, Chief Nursing Officer at Lady of the Sea. "Everything is up to current codes and standards. Along with our staff providing treatment, our patients are receiving the highest level of dialysis treatment available."

"Often, the general public is the first to respond at an accident site," said Lafont.

"Many people have been trained in CPR to be able to offer potentially life-saving assistance to those in distress. STOP THE BLEED[®] training would be another tool for people to be able to offer life-saving assistance in a bleeding emergency."

possibilities are endless for a bleeding emergency. By offering life-saving training to our community, we can potentially save lives and limit injury.

The STOP THE BLEED[®] campaign was initiated in October 2015 through the National Security Council and the White House. The purpose of the campaign is to better prepare the public to save lives by raising awareness of basic actions to stop life threatening bleeding. Advances made by military medicine and research in hemorrhage control during the wars in Afghanistan and Iraq are taught to the general public to save lives.

began to rush through the building from top to bottom, and affected our entire hospital, including the electrical system. After an exhausting 24 hours, the storm had passed, and the hospital building was declared closed.

The real work for the Plant Operations department began at that moment. Employees returned to the building to try to salvage items, and with a threestory building, plant operations was on hand to help every single group salvage what they could. This went on for days. Whole departments relocated to other areas, and then relocated again and again through the next six months.

Staffing in all departments was reduced, and this included Plant Operations.
